Dear Sir,

We were appointed as statutory auditors of S Chand And Company Limited ('the Company') in 46<sup>th</sup> Annual General Meeting ('AGM') held on September 25, 2017 for a period of 5 years and to hold office till the conclusion of 51<sup>st</sup> AGM. We last performed the audit of Company's stand-alone and consolidated financial statements for the yearended March 31, 2020 vide our stand-alone and consolidated audit reports dated June 30, 2020. We have also reviewed the Company's quarterly financial results for the quarter and half year ended September 30, 2020 pursuant to the requirement of regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and issued report dated November 11, 2020 on these results.

Further to our discussions, since your offer of audit fees for the statutory audit and the review of quarterly results for next year is lower than our existing fees for the year ended March 31, 2020 in spite of twenty percent increase in scope of work, which is not commensurate with the time and efforts in the audit engagement for next year. Considering these facts, It would be difficult for us to continue as statutory auditors of the Company. Accordingly, we regret to inform you of our inability to continue as the Statutory Auditors of S Chand And Company Limited and request you to treat this as our letter of resignation with immediate effect.

We take this opportunity to reiterate our appreciation for the courtesies and co-operation extended to us by your organization.

Detailed reasons for resignation: Company's management has requested us to consider reduction in audit fees for the year ending March 31, 2021 as compared the audit fees for the year ended March 31, 2020. Since the management's proposal for the audit fees for the statutory audit and the review of quarterly results for next year is lower than our existing fees for the year ended March 31, 2020 which is not commensurate with the time and efforts in the audit engagement for next year in spite of twenty percent increase in scope of work, it would, therefore, be difficult for us to continue as statutory auditors of the Company.
- 5. In case of any concerns, efforts made by the auditor prior to resignation (including approaching the Audit Committee/Board of Directors along with the date of communication made to the Audit Committee/Board of Directors) The Company's management has nominated Group CFO of the Company for discussion with us for reduction of audit fees considering the pandemic and cost cutting initiatives. Our discussion with Group CFO was communicated to the Audit Committee.
