DUKAN RAISES \$11M FROM 640 OXFORD VENTURES, OTHERS

DUKAN, A RETAIL platform that helps entrepreneurs set up online stores, on Monday said it has raised \$11 million (about \$80.3 crore) in funding led by 640 Oxford Ventures...

These stores are from beyond the top six cities. Dukan has also built over 1.5 million transactions for these sellers and helped TPT.
'We founded Dukan because we saw small businesses and first-time entrepreneurs struggling to digitise their presence online. We became obsessed with the idea of making the most affordable, easy-to-use, mobile-first commerce platform in the world; he added.
Dukan had raised \$6 million in a seed round from Matrix Partners and Lightspeed Partners in October last year. Shah said the latest capital infusion will allow Dukan to aggressively expand its footprint while building its team of highly skilled designers and developers.
'Additionally, this capital accelerates our ability to establish key strategic partnerships to grow our paying merchant base. We started with our monetisation journey on a small merchant base last quarter, and more than 2,000 merchants have enrolled in our Dukan premium subscription plan so far,' he said. Premium subscription contributes about 10% to the company's revenues, he added.

BIDDAN RAISES ₹17 CRORE IN FUNDING LED BY PINTEREST'S GOKUL RAJARAM

HEALTH CARE LOGISTICS Platform Biddan on Monday said it has raised ₹17 crore in a funding round led by Co-investor and social media firm Pinterest's Gokul Rajaram.
New investors PINJ Venture Catalysts UK, Anuj Srivastava and Kamakant Sharma, and existing investors Venture Catalysts and Angelist also participated in the pre-series A1 funding round.
The funding round was led by Pinterest's Gokul Rajaram, who has invested in Biddan since its inception in 2018. The company has raised a total of ₹17 crore in funding so far, including a ₹10 crore seed round in 2019 and a ₹7 crore pre-series A1 round in 2021.
Biddan is a health care logistics platform that provides end-to-end supply chain solutions for pharmaceutical and medical device companies. The company's revenue is primarily derived from its logistics services, which include warehousing, distribution, and last-mile delivery.
The company's revenue has grown significantly over the past few years, and it is expected to continue to grow as the health care industry continues to expand.
Biddan is currently in the process of raising a series A2 round, which is expected to close in the next few weeks. The company is also planning to expand its operations into new markets in the coming year.
