वेतन न मिलने से नाराज उत्तरी दिल्ली निगम के हिंदु राव अस्पताल के डॉक्टरों ने अनिश्चितकालीन हडताल शुरू कर दी। सोमवार को अस्पताल परिसर में ही तंबू लगाकर मरीजों को देखा गया। डॉक्टरों का कहना है कि जरूरत पड़ी तो कटोरा लेकर सड़क पर जनता से भीख मांगेंगे ताकि अपनी जरूरत पूरी कर सकें। लेकिन मरीजों के साथ अन्याय नहीं होने देंगे।

डॉक्टरों के मृताबिक, अस्पताल प्रशासन की ओर से उन्हें डिग्री रद्द करने और रेकार्ड खराब



करने की धमकी मिल रही है। उत्तरी निगम के सबसे बड़े अस्पताल बाड़ा हिंदू राव में मंगलवार को डॉक्टरों ने गांधीगिरी दिखाई। तंबू में मरीज देखने के साथ हाथ में तख्तियां लेकर निगम का विरोध भी किया जा रहा था। पहली बार ऐसा देखा गया कि मरीजों के लिए डॉक्टरों ने चाय

और पकौड़े की व्यवस्था की। 40 डिग्री तापमान में सड़क पर बैठकर रोगियों की सेवा को वे गांधीगिरी मान रहे हैं। इलाके के तीस हजारी, पूल बंगश, चांदनी चौक, पुरानी दिल्ली के कश्मीरी गेट से आए महिला और पुरुष रोगियों को देखकर डॉक्टर परचा लिख रहे थे। गंभीर रोगियों को दुसरे अस्पताल में इलाज कराने की सलाह भी दी जा रही थी। महिला रोगियों के साथ महिला डॉक्टरों का रवैया बिल्कुल पारिवारिक जैसा था। इस समय करीब 500 डॉक्टर हडताल पर हैं, जिनमें करीब 350 डॉक्टरों ने रोगियों का इलाज कर बताया कि वे रोगियों को दिक्कत नहीं देंगे। रेजिडेंट डॉक्टर एसोसिएशन के उपाध्यक्ष डॉ पीयूष ने कहा कि तीन महीने से वेतन नहीं मिलने से नाराज डॉक्टर पिछले दो दिनों से तीन-तीन घंटे की हड़ताल पर थे। एसोसिएशन के महासचिव डॉ संजीव चौधरी ने बताया कि उत्तरी निगम के

इस अस्पताल में 980 बिस्तर हैं। इसकी ओपीडी में रोजाना 4000 और इमरजेंसी में एक हजार मरीज आते हैं। ठेके पर काम करने वाले डॉक्टरों को हर महीने की 15 तारीख को वेतन मिलता था। 15 फरवरी के बाद वेतन नहीं मिला। जमापूंजी खर्च होने और बच्चों की फीस से लेकर घर खर्चा चलाने में जब डॉक्टरों को दिक्कतें शुरू हो गई तो वे तीन घंटे की हड़ताल पर बैठे। तीन महीने से वे शांति से बातचीत के जरिए वेतन का इंतजार कर रहे थे, लेकिन अब मजबूरन अनिश्चित कालीन हडताल का सहारा लेना पड रहा है। उन्होंने ये भी कहा कि मरीजों को परेशान करना हमारा मकसद नहीं है, लेकिन प्रशासन के खिलाफ यह कदम उठाना जरूरी है। डॉक्टरों का कहना है कि वे गांधीगिरी दिखाते हुए रोगियों को देखेंगे लेकिन उसके बाद भगत सिंह बनकर आंदोलन से भी नहीं चूकेंगे।

दिल्ली एम्स: कर्मचारियों के व्यवहार से नाखुश रहे मरीज

जनसत्ता संवाददाता नई दिल्ली, 20 मई।

देश के नामी स्वास्थ्य केंद्र अखिल भारतीय आयर्विज्ञान संस्थान (एम्स) में आने वाले ज्यादातर मरीज यहां कर्मचारियों के व्यवहार से असंतुष्ट होकर जाते हैं। सेवाओं को लेकर सबसे ज्यादा असंतोष इमरजेंसी में आने वाले मरीजों को रहा है। इस साल फरवरी से अप्रैल के बीच एम्स आने वाले करीब 9,940 मरीजों से प्रतिक्रिया मिली। केंद्रीय स्वास्थ्य मंत्रालय की ओर से शुरू की गई पहल 'मेरा अस्पताल' के तहत मरीजों से यह प्रतिक्रिया ली गई। प्रतिक्रिया मोबाइल ऐप व एसएमएस के जरिए ली गई। इनमें से 35 फीसद के बीच असंतोष की मुख्य वजह कर्मचारियों का व्यवहार रहा।

केंद्रीय स्वास्थ्य मंत्रालय ने देश भर के सभी सरकारी अस्पतालों की व्यवस्था में जरूरी सुधार के मकसद से 'मेरा अस्पताल' नाम से एक प्रणाली शुरू की है जिसमे मरीजों के अस्पताल में हुए अनुभव के आधार पर प्रतिक्रिया मांगी जाती है। प्रतिक्रिया लेने वाली प्रणाली ने पाया कि यहां आने वाले ज्यादातर मरीज कर्मचारियों के व्यवहार से नाखुश रहे। एम्स से मरीजों के असंतोष की मुख्य वजह कर्मचारियों का व्यवहार (35 फीसद) है । जिसके बाद अन्य वजहें (34 फीसद) हैं। इसमें कहा गया है कि करीब 23

शिवकांत यादव मूल रूप से यूपी के एटा का रहने वाला था। वर्तमान में उसका परिवार अलीगढ़ में रहता है। उसके पिता केबी सिंह यादव उत्तर प्रदेश पुलिस में सब-इंस्पेक्टर हैं। वह चार वर्ष पहले प्रतियोगी परीक्षा की तैयारी करने दिल्ली आया था। वह वजीराबाद गांव गली-12 स्थित एक मकान में किराए पर रहता था और मुखर्जीनगर स्थित कोचिंग सेंटर में पढ़ाई कर रहा था। पुलिस अधिकारी ने बताया कि पढ़ाई के बाद वह सोमवार तड़के चाय पीने गली नंबर-6 की ओर निकला। तभी करीब चार बजे दो हमलावारों ने उसपर चाकू से हमला कर दिया और फरार हो गए। आरोपी शिवकांत का मोबाइल नहीं ले जा पाए। घायल अवस्था में छात्र ने घटना की सूचना मोबाइल से पहले दोस्तों और बाद में पुलिस को दी।









































