वेतन न मिलने से नाराज उत्तरी दिल्ली निगम के हिंदु राव अस्पताल के डॉक्टरों ने अनिश्चितकालीन हड़ताल शुरू कर दी। सोमवार को अस्पताल परिसर में ही तंबू लगाकर मरीजों को देखा गया। डॉक्टरों का कहना है कि जरूरत पड़ी तो कटोरा लेकर सड़क पर जनता से भीख मांगें ताकि अपनी जरूरत पूरी कर सकें। लेकिन मरीजों के साथ अन्याय नहीं होने देंगे।

डॉक्टरों के मुताबिक, अस्पताल प्रशासन की ओर से उन्हें डिग्री रद्द करने और रेकार्ड खराब

डीयू के कॉलेजों में शिक्षकों की पदोन्नति में फिर बाधा

दिल्ली विश्वविद्यालय (डीयू) से संबद्ध कॉलेजी में होने वाली शिक्षकों की पदोन्नति में एक बाधा फिर बाधा पैदा हो गई है। हाल ही में एक कॉलेज का मामला सामने आया है कि जब तक एडहॉक शिक्षार्थियों शिक्षकों के मामलों पर गतिविधि कमेट्री की रिपोर्ट नहीं आती तब तक पदोन्नति में एडहॉक सेवा शामिल नहीं होगी। साथ ही पदोन्नति का आधार बिना एडहॉक सेवाओं के पदोन्नति के मामले में यूजीसी के पूर्व दिशा निर्देशों का ही पालन किया जा रहा है। एक कॉलेज के के प्राचार्य की ओर से शिक्षकों के

लखे गए पत्र से यह मामला सामने आया है। विश्ववैद्यलय की विद्वत परिषद के विश्व सदस्यों पर हंसरज सुमन का कहना है कि डीयू प्रशासन की मंशा पदोन्नति और शिक्षकों की नियुक्ति के मामले में स्पष्ट नहीं दिख रही है। बार-बार अवरोध उत्पन्न किए जा रहे हैं। उनका कहना है कि अगर रिपोर्ट नहीं आई है तो पूर्व में एडहॉक सेवा को शामिल करने पदोन्नति का जो आधार माना गया था उसी आधार पर अग्रिम रिपोर्ट आने तक पदोन्नति क्यों नहीं की जा रही। इसका मतलब है कि विवि प्रशासन वास्तव में पदोन्नति करना ही नहीं चाहता, जबकि पूर्व में एडहॉक सेवा शांतिपूर्वक रूप से पदोन्नति की जा चुकी है।

प्रतियोगी परीक्षा की तैयारी कर रहे छात्र की हत्या

वज्रीराबाद में सोमवार तड़के दो हमलावरों ने चाकू से गांधकर संघ लोक सेवा आयोग की परीक्षा की तैयारी कर रहे 28 साल के छात्र की हत्या कर दी। घटना के बाद आरोपी मौके से फरार हो गए। छात्र की पहचान शिवकांत यादव के रूप में हुई है। वह दिल्ली में रहकर संघ लोक सेवा आयोग की प्रतियोगी परीक्षा की तैयारी कर रहा था। आशंका है कि हत्या लूटपाट के लिए की गई है। उत्तरी राजधानी की पुलिस उपमुख्य नूपुर प्रसाद ने बताया कि पुलिस हत्या का मामला दर्ज कर जांच शुरू कर सीसीटीवी फुटेज खंगालकर आरोपियों की पहचान की कोशिश कर रही है।

शिवकांत यादव मूल रूप से यूपी के एटा का रहने वाला था। वदमन नरेंद्राचरण यादव का परिवार अलग-थलग रहता है। उसके पिता केला सिंह यादव उत्तर प्रदेश पुलिस में सब-इंस्पेक्टर हैं। वह चार वर्ष पहले प्रतिभोगी परीक्षा की तैयारी करने दिल्ली आया था। वह वजीराबाद गांव गली-12 स्थित एक मकान में किराए पर रहता था और मुसज्जीन-रसूल कोचिंग सेंटर में पढ़ाई कर रहा था। पुलिस अधिकारी ने बताया कि पढ़ाई के बाद वह सोमवार तड़के चाय पीने गली नंबर-6 की ओर निकला। तभी करीब चार बजे दो हमलावारी ने उसपर चाकू से हमला कर दिया और फरार हो गए। आरोपी शिवकांत का मोबाइल नहीं ले जा पाए। चायल अस्थिति में छत्र ने घटना की सूचना मोबाइल से पहले दोस्तों और बाद में पुलिस को दी।

यौन उत्पीड़न मामले में जल्द सुनवाई के लिए नोटिस

नई दिल्ली, 20 मई (भाषा)।

दिल्ली हाई कोर्ट ने जवाहरलाल नेहरू विश्वविद्यालय (जेएनयू) और यौन उत्पीड़न के मामले के आरोपी एक प्रोफेसर के खिलाफ दायर अवमानना याचिका पर जल्द सुनवाई के लिए कुछ छत्राओं की अर्जी पर सोमवार को नोटिस जारी कर विश्वविद्यालय से जवाब मांगा।

मामला

मैं अस्पताल में 980 बिस्तर है। इसकी ओपीडी में रोजाना 4000 और इमरजेंसी में एक हजार मरीज आते हैं। ठेके पर काम करने वाले डॉक्टरों को हर महीने की 15 तारीख को वेतन मिलता था। 15 फरवरी को बड़ा वेतन नहीं मिला। जमापूंजी खरूच होने और बच्चों की पीस से लेकर घर खर्चा चलाने में जब डॉक्टरों को दिक्कतें शुरू हो गई तो वे तीन घंटे की हड़ताल पर बैठे। तीन घंटे के वे शांति से बातचीत के जरिए वेतन का इंजंजार कर रहे थे, लेकिन एक मजबूर अनिश्चित कालीन हड़ताल का सहारा लेना पड़ रहा है। उन्होंने ये भी कहा कि मरीजों को परेशान करना हमारा मकसद नहीं है, लेकिन प्रशासन के खिलाफ यह कदम उठाना जरूरी है। डॉक्टरों का कहना है कि वे गांधीगिरी दिखाते हुए रीरोंगों को देखेंगे लेकिन उसके बाद भगत सिंह बनकर आंदोलन से भी नहीं चूकेंगे।

ये दिल का मामला है...

15 विभागों में से हृदय रोग विभाग से सबसे ज्यादा मरीज संछुट हुए। 84 फीसद लोग विभाग में इलाज से खुश थे। जबकि इसी विभाग में प्रतीक्षा सूची सबसे ज्यादा लंबी रहती है। डॉक्टरों की मानें, इलाज के लिए लंबी प्रतीक्षा सूची इस अस्पताल के मजबूरी है, जो यहां के गुणवत्तापूर्ण इलाज से है। यहाँ लंबी इसलिये है क्योंकि देश भर से यहां मरीज आते हैं। लेकिन जो यहां से इलाज करारक जाते हैं, उन- 31 और बेहतर जिंदगी मिलती है। आंखों के इलाज के लिए आरपी सेंटर की सेवा से खुश मरीजों व संख्या इसके बाद सबसे अधिक है। यहां पहुंचे 8 फीसद मरीजों की राय सकारात्मक थी। बालरोग विभाग और मनोरोग विभाग की भी 80 फीसद सकारात्मक प्रतिक्रिया पाई गई। ट्रॉमा सेंटर का 7 फीसद, न्यूरोलॉजी 78, मेडिसिन 79, इंडनटी 79, त्वचा विभाग के इलाज को 78 फीसद ने सफा उहारा। इमरजेंसी विभाग से 72 फीसद लोग खुश थे। जबकि 28 फीसद से असंतोष जताया

सेवाओं से संतुष्ट नहीं रहे। उनमें से ज्यादातर आपात, सर्जरी, आर्थोपेडिक, प्रसूति और महिला रोग विभागों की सेवाओं पर असंतोष जताया। प्रतिक्रिया के मुताबिक, इलाज की गुणवत्ता असंतोष की अन्य वजह रही। इसमें 13 फीसद मरीजों ने नाखुशी जताई और इलाज का खर्च, फीसद मरीजों के बीच असंतोष की वजह रहा। फोडबैक के अनुसार, 25 फीसद मरीज ईएनए विभाग की सेवाओं से खुश नहीं रहे।

At 67.11%, 2019 turnout highest for Lok Sabha polls

New Delhi, May 20

AN ESTIMATED 67.11% of the nearly 91 crore voters turned up to cast their vote in this year's seven-phase Lok Sabha elections, the highest ever turnout recorded in any parliamentary polls in India.

The overall turnout in 2014 was 66.40%. But the Election Commission figures are provisional and are subject to change.

The overall turnout was recorded at 67.11%, as per data available on Monday morning. Out of the 543 Lok Sabha

The gap between male and female voters turning out to vote is narrowing. In 2009, it was 9%, which went down to 1.4% in 2014, and now tentatively stands at 0.4%.

The poll panel is yet to announce a fresh date for elections in Vellore. While there were 83.40 crore voters in the 2014 polls, their number stood at 90.99 crore as on April 23, the day third phase of polling took place for the 2019 Lok Sabha elections.

In the 2009 elections, the turnout was pegged at 56.9%.

In 2019, the voter turnout saw a decreasing trend from the first to the seventh phase, which took place on Sunday.

According to data provided by the EC, in phase one, the turnout was 69.61%. It went down marginally to 69.44% in phase two and further down to 68.40% in the third phase.

turnout saw a dip of nearly three per cent and stood at 65.50%. In the fifth phase, the turnout was 64.16%, but went up marginally to 64.40% in the sixth and penultimate phase.

In the seventh and the last phase, it was 65.15%, according to the EC's Voter Turnout app on Monday evening.

The cumulative turnout figure of the first six phases stood at 67.34%, which is 1.21% more than the corresponding constituencies in 2014.

Madhya Pradesh's turnout was 5.92% more than that in 2014 and Himachal Pradesh's 5.1% higher than that in the last Lok Sabha polls.

Chandigarh on the other hand recorded a massive dip in turnout as compared to the last elections. The turnout went down by 10.27%.

Punjab also witnessed a lower turnout compared with 2014. The gap was a glaring 5.64%.

In most of the states the turnout was marginally higher by 2.5% than 2014.

Interestingly, the gap between male and female voters turning out to cast their vote is narrowing since 2009. In 2009, the gap was 9%, which went down to 1.4% in 2014. It now tentatively stands at 0.4%.
